3	Whereas, Article IV, Section 10 of the Constitution of the
4	State of Michigan of 1963 and MCL 15.302 provide, in relevant part:
5	"No member of the legislature shall be interested directly or
6	indirectly in any contract with the state which shall cause a $% \left(1\right) =\left(1\right) +\left(1\right)$
7	substantial conflict of interest"; and
8	Whereas, Rule 74(3) of the Standing Rules of the House of
9	Representatives states:
10	A Member shall not use his or her position in any manner
11	to solicit or obtain anything of value for himself or
12	herself, House employees or any other Member which tends
13	to influence the manner in which the Member performs his

or her official duties. 1 2 : and Whereas, Rule 74(4) of the Standing Rules of the House of 3 4 Representatives states: A Member shall not convert for personal, business and/or 5 6 campaign use, unrelated to House business, any supplies, 7 services, facilities, or staff provided by the State of 8 Michigan. This includes, but is not limited to, telephones, 9 telecopy machines, computers, postage, and copy machines. 10 ; and 11 Whereas, Confidence in government and elected officials is a prerequisite to the functioning of a democratic society; now, 12 13 therefore, be it 14 Resolved by the House of Representatives, That a House select 15 committee to examine the actions of Representative Angela Witwer is 16 created. The select committee shall consist of six members. Three 17 members of the select committee shall be from the House Democratic 18 Caucus selected by the Speaker of the House and three members of the select committee shall be from the House Republican Caucus 19 20 selected by the House Minority Leader. The Speaker of the House and the House Minority Leader shall each designate a co-chair of the 21 select committee. The House select committee shall report its 22 23 findings and recommendations to the House of Representatives; and 24 be it further 25 Resolved, That the House select committee may subpoena 26 witnesses, administer oaths, and examine the books, records, and 27 tapes of any person, partnership, association, or corporation, 28 public or private, involved in a matter properly before the 29 committee; may call upon the services and personnel of any agency

- 1 of the state and its political subdivisions; and may engage such
- 2 assistance as it deems necessary; and be it further
- 3 Resolved, That members of the House select committee shall
- 4 serve without compensation, but shall be entitled to actual and
- 5 necessary travel and other expenses incurred in the performance of
- 6 official duties, to be paid from the appropriation to the House of
- 7 Representatives; and be it further
- 8 Resolved, That copies of this resolution be served on
- 9 Representative Angela Witwer and that she be given a reasonable
- 10 opportunity to appear before the House select committee and be
- 11 represented by counsel.
