RULES

- 1. NO PURCHASE REQUIRED: There is no purchase necessary to win; purchasing Mississippi Lottery products does not increase the chance of winning. Limit one entry per person, per drawing. Duplicate entries using multiple email addresses or any other method will be disqualified.
- 2. WHO CAN ENTER: The Mississippi Lottery's NASCAR Powerball Playoff Promotion (Promotion) is open to Mississippi Lottery Insiders. Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any Mississippi Lottery promotional prizes.
- 3. ENTRIES: Mississippi Lottery Insiders will receive access to an entry form by email.

Each Promotion drawing will have a unique entry form, and entrants are encouraged to submit entries for each drawing. Each submitted entry is valid for the specific drawing only; entry forms from previous drawings do not carry forward.

Each entry form will include a list of prizes available for the specific drawing. Winners from previous drawings are ineligible to win again in the Promotion.

4. DRAWING PROCEDURE: The pool of entries for the Qualifying Race is comprised of completed entries received between 9 a.m. Central Time on the date 7 days prior to the draw through 9 a.m. Central Time on the draw date. Mississippi Lottery Insiders will receive a link to an entry form by email at the beginning of each drawing period.

Five entrants for the NASCAR Powerball PlayoffTM will be selected in each of the April 3, April 10, April 17, and April 24 drawings.

- 5. DRAWING METHOD: Promotion winners will be chosen by random drawing.
- 6. ODDS OF WINNING: The odds of winning a prize via the Promotion are based on the total number of entries for each drawing.
- 7. PRIZE ALLOCATION: Each selected entrant in the Qualifying Race in the Promotion will receive entry into the NASCAR Powerball Playoff™. In the April 3 drawing, each selected entrant will be awarded \$2,500; in the April 10 drawing, each selected entrant will be awarded \$2,000; in the April 17 drawing, each selected entrant will be awarded \$1,500; and in the April 24 drawing, each selected entrant will be awarded \$1,000. These cash prizes are awarded by the Mississippi Lottery.

All of the selected entrants from the Qualifying Race will be entered into the Champion's Race, a random drawing in which first place is awarded \$10,000, second place is awarded \$5,000 and third place is awarded \$2,500 by the Mississippi Lottery.

Notwithstanding the foregoing, a selected entrant in the Qualifying Race must submit a completed claim form and execute a publicity authorization and any other required documentation in order to receive a cash prize, be entered in the NASCAR Powerball PlayoffTM, or be entered in the Champion's Race.

Progressing through levels of the NASCAR Powerball Playoff[™] as conducted by the Multi-State Lottery Association (MUSL) may qualify an entrant for additional prizes through the NASCAR Powerball Playoff[™]. Prizes by the Mississippi Lottery are limited to a maximum of one per person for the duration of the Qualifying Race portion of the Promotion. Once an entry is selected and qualified for submission into the NASCAR Powerball Playoff[™], subsequent entries by the player are disqualified. See NASCAR Powerball Playoff 2024 Promotion Overview and Guidelines, NASCAR Powerball Playoff Promotion (2024) Trip Prize Terms and Conditions and NASCAR Powerball Playoff Promotion (2024) Trip Prize Description for further details.

8. CONTACTING WINNERS: Each winning Promotion entrant will be notified by certified mail. If the Mississippi Lottery does not receive a winner claim form

from the winning entrant within 10 days of the Mississippi Lottery receiving confirmation of the certified mail delivery, such winning entrant shall be disqualified and the Mississippi Lottery, at its discretion, may randomly choose another qualified entrant to receive the prize from the same pool of entries.

9. WINNER REQUIREMENTS: Each Promotion winner will be required to submit proper identification and complete a winner claim form – the same process used for prize claims for Mississippi Lottery games. Claims made whether in person or by mail must be received by the Mississippi Lottery within the prize claim period specified in Section 8 above. The name and physical address on the entry, claim form and identification must match. The Mississippi Lottery is not responsible for lost or stolen mail, and claims received after the deadline will be rejected.

MUSL plans to publicize national semi-finalists' names in the NASCAR Powerball PlayoffTM. Promotion winners selected by the Mississippi Lottery to participate in the NASCAR Powerball PlayoffTM will be required to sign a release form authorizing MUSL to publicize the participant's name if chosen as a national semi-finalist. Failure to sign the release form authorizing such publicity will result in forfeiture of all aspects of the Promotion winner's prize, and the Mississippi Lottery, at its discretion, may randomly choose another qualified entrant to receive the prize from the same pool of entries.

- 10. WINNERS LIST: The Mississippi Lottery will maintain a list of Promotion winners and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.
- 11. NO PRIZE EXCHANGE: All Promotion prizes will be awarded as described. No substitutions.
- 12. TAXES: All federal, state, and local taxes on the total prize value, if applicable, are the responsibility of the winner. The MLC will withhold and deposit the initial state and federal taxes on behalf of the winner, as required by law. An IRS Form W-2G/1099 will be issued to the winner if required by law.
- 13. CONTEST ENTRIES AND PRIZE LIMITATIONS: Limit of one entry per person/email address for each drawing. Limit of one prize per household within the Promotion.

Entries generated by script, macro or other automated means which subvert the entry process are void. If it is discovered an entrant has submitted, attempted to enter, or used multiple accounts to enter more than the stated limit, all Promotion submissions for the entrant will be disqualified, and the entrant may be barred from future promotions, at the sole discretion of the Mississippi Lottery. All entries become the property of the Mississippi Lottery and will not be acknowledged or returned.

- 14. RELEASE OF LIABILITY: All entrants in the Promotion agree the Mississippi Lottery shall have no liability for any personal injuries, death, property damage, or other damage or expenses resulting from or arising out of any aspect of use or acceptance of the Promotion prize and participation in the NASCAR Powerball Playoff.
- 16. DISPUTE RESOLUTION: The venue for any dispute arising under and/or as a result of the Promotion shall be the appropriate court in Rankin County, Mississippi.
