Executive Summary

[State law](#) requires the Ohio Department of Education and Workforce to conduct an annual audit of each city, local and exempted village school district regarding its compliance with the requirements for venereal disease and sexual education instruction. This document consists of the audit findings from Ohio school districts that self-reported information regarding venereal disease and sexual education instruction and course materials used during the 2022-2023 school year. This audit will be conducted annually, and its findings will be published on the [Department's website](#).

Compliance is based on the responses to Questions 1 and 2 (*see below*). Districts are required to self-report relevant information regarding venereal disease and sexual education instruction to the Department. The window to have completed the audit for the 2022-2023 school year was March 15-Aug.1, 2023. The Department sent email notifications and reminders directly to school superintendents regarding the audit reporting requirements and deadlines. The Department also notified districts through the Department newsletter, EdConnection, Urban Leaders Chief Academic Officers, monthly calls, communication with educational service centers, conference presentations and virtual meetups. Technical support was provided to districts via phone, email and virtual meetups to assist districts with the process during the audit window. The final audit shows that 100% of districts completed the information for the audit. Districts that have an “Overall Non-Compliant” status received a phone call and a noncompliance letter from the Department stating the reason(s) for non-compliance.

District Reporting Status:

- **Completed** – Districts that answered yes to both questions 1 and 2 and submitted their information in the system.
- **Not started** – Districts that did not enter the system to submit their information.
- **In Progress** – Districts that did not completely answer questions and did not submit their information; or districts that entered the system but did not answer any questions.

Compliance:

- **Overall Compliant** – Districts that answered “yes” to questions 1 and 2 and submitted their responses.
- **Overall Non-Compliant** – Districts that answered “no” to questions 1 and/or 2 or did not completely answer questions 1 and/or 2 and submitted their responses.
- **Overall, Not Submitted/Non-Compliant** – Districts that may have answered questions 1 and/or 2 but did *not* submit their responses.

Districts were placed into one of three categories based on reporting status. A large majority of districts completed the reporting requirements.

Audit Questions

Audit Question 1

Pursuant to Ohio Revised Code (ORC) 3313.60, did the district offer venereal disease and sexual education instruction during school year 2022-2023?

If yes, please provide the name of any organization or program that provided venereal disease and sexual education instructional materials.

If no, please explain your answer.

Note: School districts and schools are not required to upload documents as part of the Annual Venereal Disease and Sexual Education Instruction Audit. Any uploaded documents will not be considered for compliance.

Audit Question 2

Did the district offer course material and instruction in venereal disease and sexual education courses, pursuant to Ohio Revised Code 3313.6011, that do all of the following?

- Stress that students should abstain from sexual activity until after marriage.
- Teach the potential physical, psychological, emotional and social side effects of participating in sexual activity outside of marriage.
- Teach that conceiving children out of wedlock is likely to have harmful consequences for the child, the child's parents and society.
- Stress that sexually transmitted diseases are serious possible hazards of sexual activity.
- Advise students of the laws pertaining to the financial responsibility of parents to children born out of wedlock.
- Advise students of the circumstances under which it is criminal to have sexual contact with a person under the age of sixteen pursuant to section 2907.04 of the Ohio Revised Code.
- Emphasize adoption as an option for unintended pregnancies.

2b. If the school or district offered instruction in venereal disease and sexual education beyond what is outlined in ORC 3313.6011, was parental notification provided?
