HOW THE POLL WAS CONDUCTED

This poll was conducted by Mason-Dixon Polling & Strategy, Inc. of Jacksonville, Florida from April 15 through April 19, 2021. A total of 1,100 registered voters were interviewed nationwide by telephone.

Those interviewed were randomly selected from a nationwide voter registration list that included both land-lines and mobile phones. Quotas were assigned in order to reflect voter registration by state.

The margin for error, according to standards customarily used by statisticians, is no more than ± 3 percentage points. This means that there is a 95 percent probability that the "true" figure would fall within that range if all voters were surveyed. The margin for error is higher for any subgroup, such as a gender or age grouping.

QUESTION: The filibuster requires that 60 Senators must vote for a bill before it can come to the floor of the Senate for a final vote. The filibuster is designed to slow the process so that there is more debate and that final approval of a law has some level of bi-partisan support.
