


Click on the lefthand tile to create a new LMIC+ account. You will need to register before you can access your CLE on LMIC+.



### **Can I share my Lawyers' Mutual member benefits login info with other attorneys at my firm?**

Every attorney listed on your policy should have their own Lawyers' Mutual Member Benefits account before creating LMIC+. If this isn't the case, please email [MCLE@lawyersmutual.com](mailto:MCLE@lawyersmutual.com) to assign them a personal username and password.

### **What's the difference between my Lawyers' Mutual member benefits password and my LMIC+ password?**

Your Lawyers' Mutual member benefits login grants you access to all your exclusive free member benefits. Your LMIC+ login gives you unlimited access to the new portal to your free Lawyers' Mutual CLE content.

### **Can I also access BHBA OnDemand CLEs?**
