Installation Instructions

Windows 8, Windows 10 and Windows 11 Operating Systems only.



***Please note** – Windows 7 and Windows Server 2008 are no longer supported by Microsoft and, as such, pose a security risk. This version of Cattle Manager **will not install** onto machines that still use this operating system. Any data that needs to be fixed by our support team will be updated using this version so it is important that you upgrade, or you may lose access to your data. Please contact Farmplan to discuss upgrading your PC if this is applicable.

- Before you start, ensure that you have read about the enhancements.
- You will not be able to load this version of the program if your licence has expired. If you are getting messages telling you that your licence has expired but you have renewed your contract, take the option **File – Licence – Get Key** BEFORE you load this version of the program.
- Remember to make an up-to-date backup of your Livestock Manager data.
- The option to install the latest version of the program can be found under **Livestock** in the **Support & Downloads** area of the Farmplan website (www.farmplan.co.uk). You will need your customer number.
- Make sure that all Farmplan programs are closed.
- Follow the on-screen instructions to '**Download**'. The exact procedure will vary according to the version of Windows and browser that you use but just follow the instructions on the screen. You will download a file called **setup.exe**, supplied by LNRS Data Services (our parent company), which should then be 'Run'.
- If Windows SmartScreen (a warning message) appears to block the installation, click on **More Information** and then **Run Anyway**.
- A black box may appear on your screen during the installation. Ignore it – it will disappear when the installation is complete
- If you encounter any installation issues it is worth repeating the installation process by right clicking on the setup.exe file and running as administrator.
- When the installation is complete go into the program – your data will be automatically updated to run with the new version (1.46) of the program.

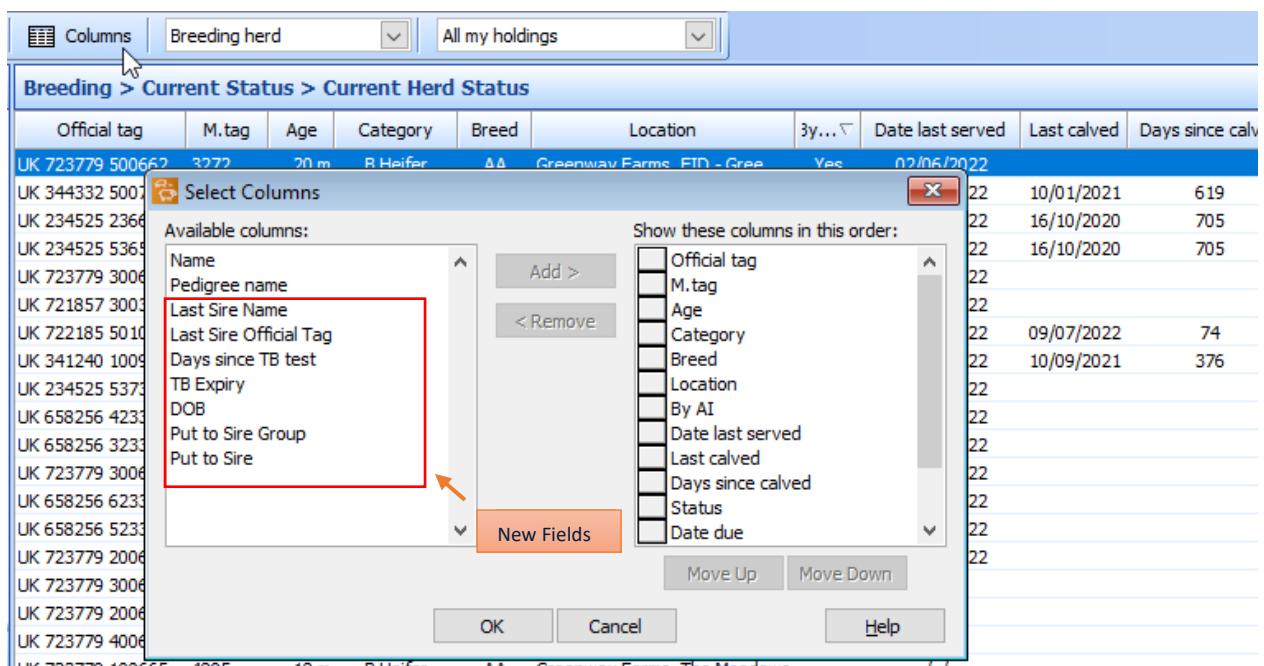

Breeding Reports

Livestock Manager already contains detailed reports about the status of each breeding animal both on the screen and as a report. To further enhance the management information available we have increased the number of reporting fields throughout the program.

Current Herd (Flock) Status – this screen display is available from the **Breeding Section** on the side bar. It contains a number of columns with details of the current breeding status of each breeding cow and heifer.

The default layout can be customised to select additional columns to this display by using the **Columns** button or by **RIGHT CLICKING** on the column heading bar.



The columns on the right-hand side are the ones that are currently displayed but a number of additional columns can be selected from the left by highlighting the one that you want to add and clicking on **Add**.

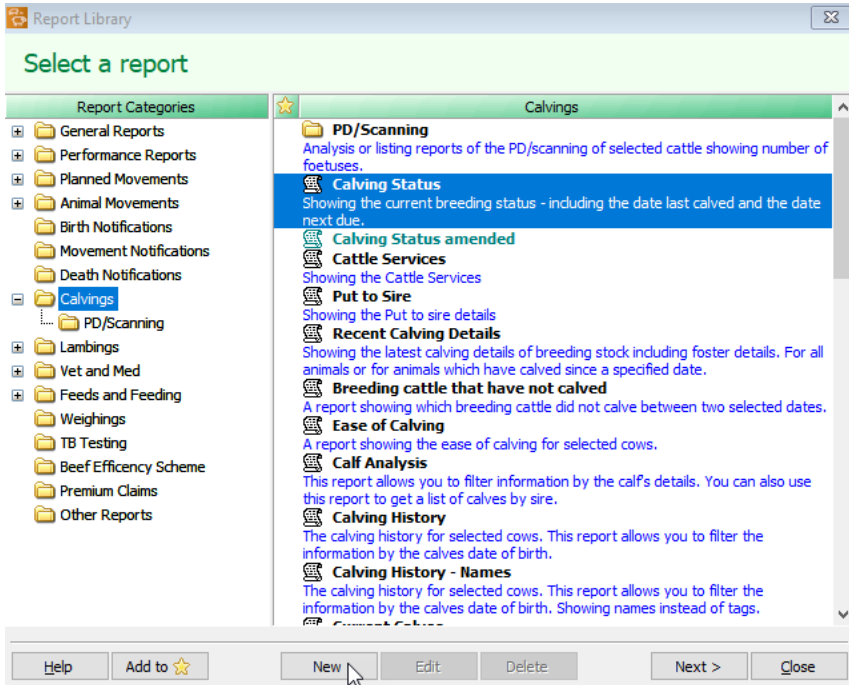
To rearrange the order of the columns, click on the one that you want to move and use the **Move Up** and **Move Down** buttons.

NB you may wish to experiment with this because, of course, the number of columns that can be displayed is limited by the width of your screen. Columns can be removed and clicking on **Reset** will return the layout to the Farmplan default.

Remember that you can sort the order of the records displayed by clicking on their heading.

***Calving (Lambing) Status Report** – A similar report is available from the **Report Library**. In addition to being able to customise the columns on it, you can also filter it by a number of different factors.

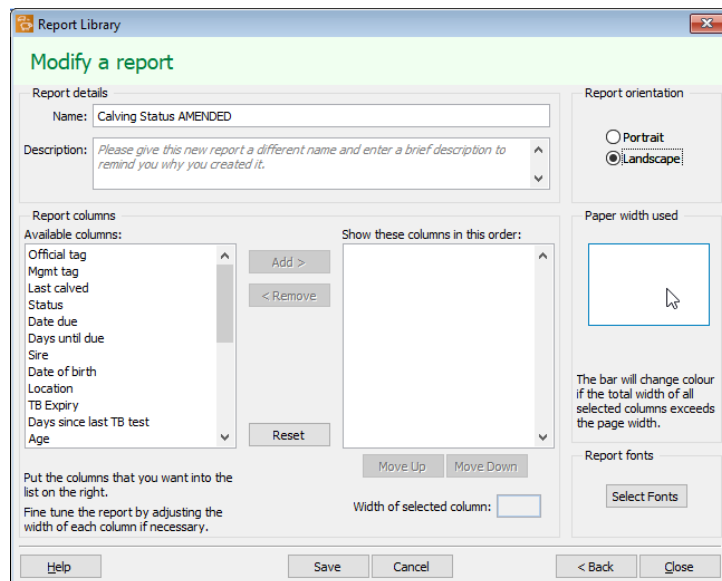
In **Report Library – Calvings (Lambings) – Calving (Lambing) Status**, select the **New** button at the bottom of the screen.



From here you will be able to select the columns that you wish to **Add** to the report. Like the screen version, you can move the order of the columns and also change their widths. You will be limited by the size of an A4 sheet of paper but can change the layout to landscape to make it wider.

The new fields available include:

- Age
- Category
- Breed name
- Days since last calved
- Services
- PD/Scans
- Name
- Pedigree Name
- Sire Name
- Sire official tag
- Date served
- AI
- Put to sire date
- Put to sire group



Once you have saved your new layout, you will be taken the **Order** and **Filter** screen to further customise the data to be reported. Full instructions are included in the program's Help.

You can add multiple new report layouts to cover different reporting requirements.

In addition to enhancing the information available on the existing breeding status reports we have added 2 new reports to provide more management details.

Service Report – this report has been designed to replicate the columns which are already available on from the **Side Bar – Cattle (Sheep) Services**. It is located in the **Report Library – Calvings (Lambings)** and has the additional benefits of the ability to be filtered, ordered and sorted.

Herd Register – Died before Identified

The statutory herd register shows all of the movements on and off each holding since a specified date and should be available for a farm inspection.

We have updated this report so that it now shows any calf that died before it was identified as well as all live births.

*Batches/Herds/Flocks – Number of animals

Animals can be allocated to one herd or flock, plus any number of user defined batches in order to be able to filter them out for actions such as treatments or to pick specific animals in a report.

The animals in each group can be viewed by using the Groups option at the bottom of the **Inspector** screen which is accessed from the Side Bar.

*Report Library – Inspector Reports

In a similar way to the Breeding reports above, it is possible to customise the **Cattle** and **Sheep Inspector** reports by editing them and picking additional columns.

New columns include:

- Purchased From i.e. Trader Name
- Sex – i.e. Male or Female (Sheep Inspector)
- Milk Withdrawal
- Meat Withdrawal

Withdrawal Periods

It is important to keep track of the withdrawal periods of any veterinary medicines to ensure that meat or milk does not go into the food chain while the animal is still in a withdrawal period.

When a drug is used, the withdrawal date is calculated by the program. If an animal is in a withdrawal period, you will see a warning marker against it when it is selected for a Planned Movement.

We have extended this feature so that you will now see the latest Withdrawal Date on the animal's Record Card.

Animal Medical History Report

A new report has been added to the **Report Library** which combines all the drug treatments and health actions, problems, and tests into one report for the set of selected animals.

For example, when you sell a batch of animals, you may be asked to provide all of the medical history for all of those animals to the new owner.

Filter Medicine Book – exclude ancillary animals

It is now possible to choose to include/exclude ancillary animals from filtered versions of the **Medicine Book** reports.

New Action – Shearing (sheep only)

A new health action has been added so that users can record shearing as a health record. (**Treatments – Health Actions**). This will be displayed on the animal's record card under **Medical History** and will be reflected in the new **Animal Health Record** report. It will also be available for selection if used in conjunction with the Animal Logger module on the Psion.

Urgent Messages

Farmplan have the ability to send a message directly to your program to inform you of news or details such as your new licence being available after being updated. They are highlighted at the bottom of the **Home Page**, and we recommend that you should read them as soon as possible by clicking on the **Message Centre**.

Very occasionally we have something very important to tell you that we feel you should know about before you go any further – for example if CTS or ScotMoves are not working, or we have an office closure. To be sure that you do not miss it we have now prioritised certain messages so that this new category of message is displayed in full and must be dismissed before you can carry on using the program.

Business Details – email address extended

The number of characters allowed for the Business email address (in **Setup- Business Details**) have been increased from 30 characters to 50. This can then be displayed in full on any relevant **Market Declaration** reports where relevant.

CTS Breed List – updated

The list of available official cattle breed codes has been updated to replace IN95 and IN95X with INRA and INRAX.

ABP – Movement Documents

The layout of the movement documents has been updated to the latest version and will now display any Northern Irish tags in full.

ABP – Import Kill Data

The import of the file containing ABP slaughter details has been altered to be compatible with their latest layout.

Ability to edit Off-Movements after notifying BCMS/CTS


Occasionally you may have submitted a movement such as Sale, Movement between Holdings or Death to CTS, and then realised that you have made an error such as including the wrong animal or entering the wrong date.

Until now you were unable to make the change yourself and the only way to edit your record was to ask us to make the change for you which involved supplying us with a copy of your data which we appreciate takes time as you cannot work on your data temporarily.

We have made a change to this process to let you make this alteration yourself to correct your records.

NB it is very important that you still contact BCMS/CTS to notify them about the error. You will be warned if you make a change to a movement that has been notified to remind you that this must be done.

Enhancements already on Shelf Version (1.45)

A few minor new features have been included since the last major release of the program but had already been added to the last version on our website. These include:

- The standard **Market Declaration** report now includes the statement - *All of the animals in this consignment have originated from establishments that have received regular animal health visits from a veterinarian for the purpose of the detection and signs of disease.*
- **ScotMoves Cross Check** now checks for differences in Breed, Date of Birth, Sex and Dam
- **Woodhead Bros – Sheep Declaration Form** has been updated to the latest layout

Cattle Manager Go

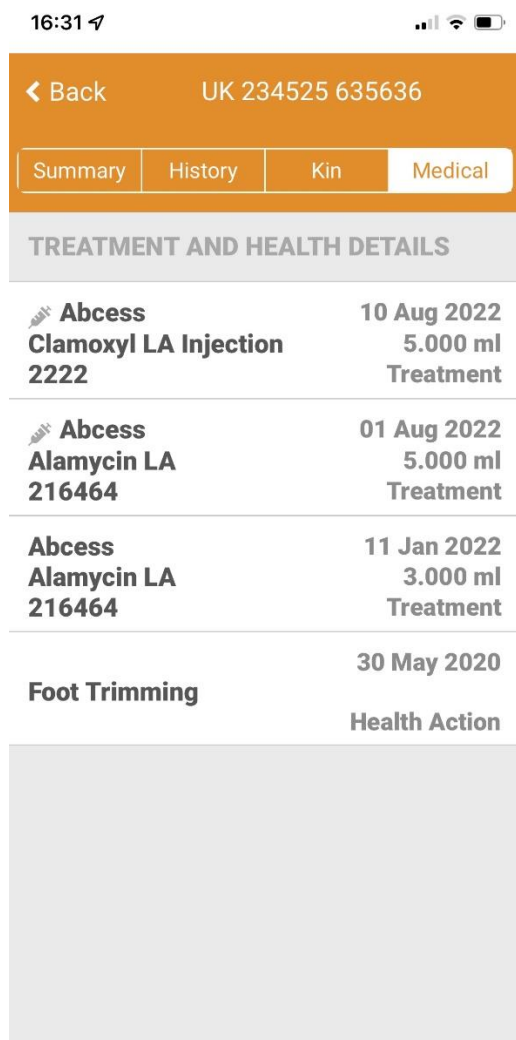

2 new features have been added:

Withdrawal Period

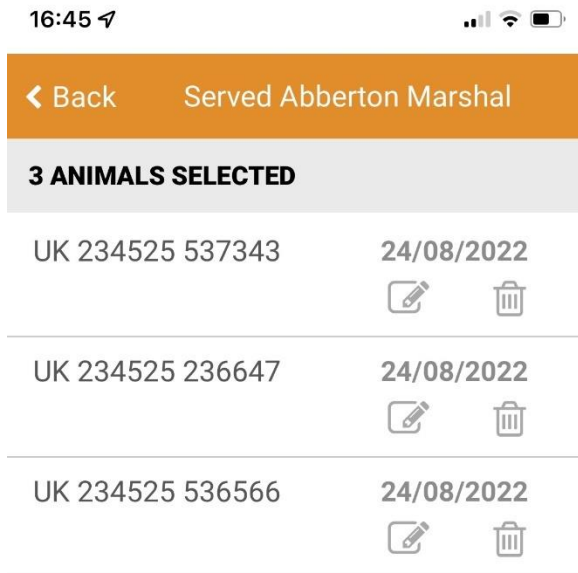
If an animal is in a withdrawal period, following a drug treatment then a syringe will be displayed on their record card under the **Medical** tab.



Services

The ability to record **Services** has been added to the list of potential actions that can be recorded using the Mobile App.

Remember to add the new action in the main program under **Setup – Devices – Setup Cattle Manager Go** so that it is sent to the mobile app and is ready to use in the **Record Actions** option.
