#### AFFIDAVIT of PROBABLE CAUSE

Your affiant is a sworn Pennsylvania State Trooper, assigned to the Troop G Lewistown-Criminal Investigation Unit.

On 04/25/22 at approximately 1545 hours, I received information from Olivia Marie GAMBLE that a juvenile student (TPS) at Juniata High School was engaging in a sexual relationship with Peyton William HARRIS (DEFENDANT). It was reported that HARRIS is a substitute teacher at Juniata High School, as well as an assistant track coach for the Juniata High School track team.

Throughout the course of this investigation it was discovered that at the time of this incident the DEFENDANT was employed as a substitute teacher/paraprofessional aid through the Substitute Teacher Service; the DEFENDANT had began substitute teaching in February of 2021 and taught in Perry (Newport High School) and Juniata County (Juniata High School). The DEFENDANT was also an assistant track coach for the Juniata High School track team during the 2021 and 2022 spring track seasons.

On 04/29/22 at approximately 1500 hours, TPS was interviewed at PSP Lewistown regarding this case. At this time TPS stated that he and the DEFENDANT had kissed in approximately July of 2021. TPS advised that the DEFENDANT was an assistant manager for the high school track team during the 2020-2021 school year, the school year prior to this incident occurring. TPS also reported that the DEFENDANT had multiple nude photos and videos of TPS in his possession. TPS related that during a party at the DEFENDANT's residence (89 Zimmerman Boulevard-Milford Township, Juniata County) on an unknown date, the DEFENDANT recorded TPS engaging in sexual intercourse with a female without either party's consent. TPS also stated that the DEFENDANT had pictures of TPS measuring his own penis with a ruler. TPS stated the DEFENDANT had other nude images of TPS in his possession; TPS couldn't clarify what other types of nude images the DEFENDANT had of him, but related he "knows there's more". TPS believed that the video and photographs taken by the DEFENDANT were taken on the Snapchat application on the DEFENDANT's cell phone; TPS stated he knew this because he received

some of the images from the DEFENDANT on Snapchat. TPS provided the Snapchat username "peyton.harris7" as the DEFENDANT's Snapchat account. TPS also stated that the DEFENDANT has a fake ID card that he uses to purchase alcohol, and that the DEFENDANT was provided him alcoholic beverages in the past.

At the time these incidents occurred, TPS was 16 years old (DOB 09/29/04).

On 04/30/22 at approximately 2125 hours, a search warrant was requested for the DEFENDANT's electronic communication devices, this warrant was authorized by Common Pleas Judge Andrew BENDER.

On 04/30/22 at approximately 1100 hours, the DEFENDANT traveled to PSP Lewistown and was interviewed regarding this case. During the interview HARRIS acknowledged that he is a substitute teacher at Juniata High School through the Substitute Teacher Service, and that he was an assistant track coach for the Juniata High School track team during the 2021 and 2022 track season. The DEFENDANT provided statements consistent with those of TPS. The DEFENDANT related that he and TPS kissed in July of 2021. The DEFENDANT then stated that in June of 2021, he had a party at his residence (89 Zimmerman Boulevard-Milford Township, Juniata County) where he provided "seltzers" for TPS and two other females. The DEFENDANT confirmed he had a fake ID card he sometimes used to purchase alcohol. The DEFENDANT related that during the party, he took pictures of TPS running around the house naked, as well as videos of TPS engaging in sexual intercourse with one of the females at the residence. The DEFENDANT also recalled taking a picture of TPS as he was measuring his penis with a ruler. The DEFENDANT acknowledged that he sent the images to TPS, but did not think he sent them to anyone else. The DEFENDANT also believed all of the images were obtained through Snapchat. The aforementioned search warrants were executed and the DEFENDANT's electronic items were seized before the DEFENDANT was released without incident.

On 05/03/22, Juniata High School administrator Benjamin FAUSEY was notified of this incident over the telephone. At time FAUSEY confirmed that the DEFENDANT was a substitute teacher and assistant track coach at Juniata High School-Juniata County School District.

Throughout the course of this investigation, interviews were conducted with the two females at the aforementioned party that occurred at the DEFENDANT's residence on 06/20/21. Both females (OML, KDM) provided statements alleging that a variety of alcoholic beverages were provided to them by the DEFENDANT at the time of the party.

On 05/19/22 at approximately 0945 hours, a search warrant was requested for the records associated with Snapchat account "peyton.harris7", this warrant was authorized by Common Pleas Judge Andrew BENDER.

On 06/10/22 at approximately 1156 hours, I received notification from Snap Inc. Law Enforcement Operations that the requested information was available for download. These contents were downloaded, burnt onto a disc, and entered into evidence under Property Record G04-9183A. Within the Snapchat records were images and videos consistent with the interviews provided by TPS and the DEFENDANT. Videos of TPS engaging in sexual intercourse with a female were discovered; records indicated that on 06/20/21, the aforementioned videos were taken and sent to Snapchat account "typarrish2". The videos were also discovered to have been sent to Snapchat account "everly.j" on 07/14/21, and to "typarrish2" a second time on 09/01/21. Multiple nude photographs of TPS were also discovered in the requested records; records show that these items were also sent to various Snapchat users on various dates.

I respectfully request the DEFENDANT, Peyton William HARRIS, answer to the charges set forth. I request an arrest warrant be issued for the DEFENDANT.
