Your Affiants are empowered by law to conduct investigations and make arrests for offenses involving violations of the Crimes Code of Pennsylvania. In the course of his/her official duties, your Affiants have personally been involved in an investigation into allegations of Child Sexual Assault.

On Monday, October 24, 2022 the 49th Statewide Investigating Grand Jury issued Presentment No. 5, recommending that criminal charges be filed against Robert B. Ostrander, (DOB 02/14/1966) for violations of the Crimes Code of Pennsylvania. The aforementioned Presentment was accepted by the Honorable Richard A. Lewis, Supervising Judge of the 49th Statewide Investigating Grand Jury by Order dated October, 24, 2022.

Having read and reviewed the Presentment, and after having participated in this investigation and considering all the facts and circumstances, your Affiants are adopting the Presentment and incorporating it fully into this Affidavit of Probable Cause (A copy of the Presentment is attached hereto). Based upon our review of the testimony given before the Grand Jury and the documents produced for the Grand Jury, we believe that the testimony of the various witnesses is accurately summarized in the Presentment and that the records referred to in the Presentment are stated accurately.

Based upon our review of the evidence, we have concluded that there is probable cause to believe that Robert B. Ostrander engaged in illegal activities which are accurately summarized in the attached Presentment. Your Affiants determined that there is probable cause to conclude that Robert B. Ostrander violated the following laws of the Commonwealth of Pennsylvania:

INTRODUCTION

We, the members of the Forty-Ninth Statewide Investigating Grand Jury, having received and reviewed evidence regarding violations of the Pennsylvania Crimes Code occurring in Cambria County, Pennsylvania pursuant to Notice of Submission of Investigation No. 3, do hereby make the following findings of fact and recommendation of charges.

OVERVIEW

In 2019, the Office of Attorney General received a resource referral from a District Attorney's Office pursuant to the Commonwealth's Attorneys Act. As a result, the Grand Jury undertook the investigation of allegations of sex assault involving members of the Jehovah's Witnesses and learned of several incidents of sexual assault committed by different members of the Jehovah's Witness religious organizations.

In the course of its investigation, the Grand Jury learned of allegations of sexual abuse committed by Robert Ostrander ("Ostrander") (DOB: February 14, 1966). It was determined that Ostrander abused two minors, including his own stepdaughter.

FINDINGS OF FACT

Ostrander and his family, including his step-daughter T.R. were active members of a Jehovah's Witness congregation. As a result of that membership and the relationships he and his family enjoyed, T.R. became friends with L.K. and Ostrander was given unsupervised access to L.K.

The Grand Jury obtained documents indicating that T.R. (DOB: January 30, 1989), had made reports of abuse. The Grand Jury received testimony both from T.R. and L.K. (DOB: January 15, 1990). Both revealed that they were regularly sexually assaulted by Ostrander when they were in their mid-teens. These assaults occurred in Cambria County.

T.R. stated that Ostrander had been physically abusive of her mother, leaving her with facial bruising on at least one occasion. Ostrander physically abused T.R. as well and, at one point, threw her down a flight of steps.

By age 15 the abuse of T.R. became sexual. Ostrander repeatedly groped T.R.'s genitals and breasts over a period of two and a half years. T.R. related that Ostrander would subject her and her friend to unusual forms of "discipline" by making them lie on the floor with their legs spread apart. On other occasions, Ostrander would grope the breasts and/or buttocks of T.R. and L.K., often under the ruse of wrestling or rough-housing. T.R. reported that she could recall incidents of sexual abuse where Ostrander was clearly aroused and ejaculated. T.R. told L.K. that, in addition to abuse Ostrander performed when the friends were together, he also sexually abused T.R. in private.

The Grand Jury also heard testimony from L.K. L.K. corroborated T.R.'s account. L.K. recalled that she would have been approximately 15 or 16 years old at that time of the abuse. She stated that Ostrander would often make comments about her body and how much he liked it. He used wrestling as an excuse to grope her breasts and buttocks. She recalled times playing in a pool with T.R. when Ostrander would join them and attempt to pull down L.K.'s swimsuit. L.K. confirmed that T.R. had told her that Ostrander was committing additional sexual assaults against T.R. in private. She remembered that T.R. told her that Ostrander "came" on her.
