Professor Rosen joined the law faculty at SIU in 2020 from the Office of Advocacy at the U.S. Small Business Administration. While there he also served as a Professorial Lecturer in Law and Visiting Scholar at the George Washington University School of Law. Before that he served as the Abraham L. Kaminstein Scholar-in-Residence at the U.S. Copyright Office, and has also taught at law schools including the Maurice A. Deane School of Law at Hofstra University and the University of New Hampshire School of Law. He is particularly known as an expert in copyright law but also has expertise in business law, including bankruptcy and related areas.

SIU Legal Clinic receives ISBA Excellence in Legal Education Award
