## Fellowship Program Disclaimers

**Sugary Drinks and Ultra-Processed Foods Affiliation:** Fellowship applicants confirm that they do not have an affiliation with the sugary drinks or ultra-processed food industry, its agents or associates, and have not had such an affiliation in the two years prior to this application; and that they currently do not accept and shall not accept financial or other support from any sugary drinks or ultra-processed food product manufacturer or the parent, subsidiary, or affiliate of a sugary drinks or ultra-processed food product manufacturer until at least five years after the completion of education. Failure to comply with this clause will constitute grounds for terminating the Fellowship and require the return of any funds awarded under the Fellowship.

**Tobacco Affiliation:** Fellowship applicants confirm that they have not had any business relationship with or knowingly received payment or other support from any tobacco product manufacturer or wholesaler, or from any e-cigarette or vaping manufacturer or wholesaler ("These Industries"), or any parent, affiliate, subsidiary, organization, or foundation with majority support from These Industries, or any person, interest group, advocacy organization, or other business or organization (other than a law firm, advertising agency, or accounting firm) that represents the interests of the Tobacco Industry (collectively, "These Affiliates") in the past two years prior to their application. Fellowship applicants and nominators currently do not accept and shall not accept financial or other support from These Industries or These Affiliates until at least five years after the completion of education. Failure to comply with this clause will constitute grounds for terminating the Fellowship and require the return of any funds awarded under the Fellowship.
